



BEYOND THE PULPIT

The Abortion Debate — LET US CONSIDER...



Throughout the centuries there have always been different life issues that have generated dialogue and debate. Most recently across the world, and currently in Jamaica, the topic of abortion has sparked heated debates between the Church and society.

The debate always invites an individual to state whether they are for or against the act of abortion. In reality, with our human limitations, and of course Christian convictions, the tendency in finding answers to some of the most difficult issues in life is for one to see the issues through the lens of "black or white." Truth be told, in experiencing life, its strivings and struggles, to choose "black and white" for the issues we are confronted with, takes us into a space where we discover that there are many "grey areas." It is not as easy to choose and/or make a decision, as we make things out to be, even with our Christian convictions.

The debates about abortion have revealed and highlighted that the case for or against abortion is filled with many grey areas. As a Christian woman (and I am Christian before being Pastor), I could never agree to the act of abortion based an irresponsible behaviour and a lack of regard for life. However, let us not be oblivious to the fact that there are some medical realities, for example, a life and death situation that involves mother and foetus that may invite the mother to make a decision.

At the heart of the debate is the right of the mother to make her own decision whether or not to go through a pregnancy. With this right, the burden then becomes that of the mother to deal with the consequences of her action.

All cases re a decision to do an abortion should not be dealt in the same vein, each case ought to be dealt with on its own merit. Be reminded, as humans we

are not the ultimate judge of people's action/s. The task of being ultimate judge is God's prerogative.


The aim of this intervention is to:


